#### APRIL IS CHILD WELFARE MONTH

For the 25th consecutive year, April is being celebrated as Child Welfare Month by The American Legion, as a means of giving special emphasis to one of our major year round programs.

The American Legion's Caild Welfare programs were first formed on the battlefields of trance during World War I where shared dangers and hardships created a deep sense of responsibility for the children of fallen comrades.

In 1925 a National Child Welfare Division was established at national headquarters in Indianapolis. Since then expenditures by the Legion and its associated groups have been in excess of 180 million dollars. About 50,000 volunteer child welfare workers take part annually in the program.

After World War II, the National Child Welfare Commission recognized the need to place added emphasis on sound public programs for all children in order to fulfill the purpose of guaranteeing care and protection to children of veterans—"A Square Deal for Every Child," became its motto.

The program has evolved into a universal awareness of the great importance attached to the preparation of America's future citizens and leaders to face the physical demands and spiritual challenges which will confront them in the increasingly complex world of tomorrow.

During 1963, the Legion's Child Welfare program is keyed to the theme—"Challenge of Change." Recognizing that today's younger generation is challenged by some of the greatest political, social, technological, and economic changes in the history of man, the Legion is stressing that the survival of these youngsters and the perpetuation of cur American heritage require that today's youth be armed with a sound, basic system of moral values.

While The American Legion realizes that the improvement of conditions for all children has required the meeting of the physical needs of a particular moment—food, clothing, shelter, medical care, etc.—there is an even greater need for strengthening their spiritual armament as preparation for the inevitable challenge which awaits them.

America's future is staked on the 70 million youngsters of today. Recognized as a pioneer of much of the modern concepts of present-day child care, The American Legion—as an organijation of the veterans of the Twentieth Century's three great wars—is confident that a truly better tomorrow awaits these youngsters if today's adults will lead them in the way of acquisition of sound moral values which have withstood the "challenge of change" through the ages.

# "To Care for Him Who has Borne the Bat-His Widow and his Orphan"

The 1963 American Legion Rehabilitation Seals have been mailed to each member of the Legion and the Auxiliary. The money contributed for these stamps goes to the department hospital committee to make life a little happier for the veterans hospitalized at the two VA hospitals at Lyons and East Orange, the two soldiers' homes at Menlo Park and Vineland, and the four state hospitals at Ancora, Trenton, Marlboro and Greystone Park.

While the Federal Government and the State provide the buildings and medical facilities, little provision is made for the personal needs of so many who cannot provide for themselves.

The hospital committee of the Legion and Auxiliary provides entertainmentcard parties, ward parties, carnivals, clam bakes, dances, sports equipment. TV sets, distributes cigarettes, tobacco. writing paper, books, magazines, and many other items. At Christmastime each veteran patient is remembered with a gift.

A small loan fund is set up for patients who are able to leave the hospital to tide them over until their first pay checks are received, or who are permitted to go home for the week-end but do not have the bus fare.

These programs help the hospitalized veteran realize he is not forgotten. These contacts with the outside world contribute much to the morale of the physically convalescent and are of definite therapeutic value to the mentally ill, according to the superintendents of the hospitals.

Some of the contributions are used to supply additional service in our Service Office at the VA Regional Office in Newark where the workload is increasing daily. There the veteran, the widow and the orphan may avail themselves of the advice and assistance of our personnel who have their interests at heart, and devote their time and energy to secure their entitlements under the law.

Please make your contribution immediately so that the committee will be able to make plans for the coming wear.
